Terms and conditions of the "Discount for new customers"

§ 1 GENERAL PROVISIONS

§2 RULES

§3 CONDITIONS OF PARTICIPATION AND COURSE OF THE PROMOTION

- 3. Complaints will be considered by the Organizer within 7 (seven) days from the date of their arrival.
- 4. The participant will be notified of the manner of processing the complaint by registered mail or by email depending on the form of the complaint submitted to the address provided in the application, within 7 (seven) days from the date of consideration of a given complaint.
- 5. Claims not considered or taken into account in the complaint procedure may may be asserted before a common court of law.
